#### **Musings from Pastor Dan**

Richard J. Mouw wrote an article for First Things entitled, "My Favorite Heretic – Why We need Heretics." He wrote, "I tell my students that it is a good thing to have a couple of favorite heretics. Some false perspectives are illuminating, and it can be healthy for Christians who love ideas to be challenged regularly by perspectives that we can disagree with in productive ways."

I agree and it caused me to recall my favorite heretic. This article reflects upon that person, and you should be able to guess why by the end of the article.

Throughout church history, many notable people have contributed directly and positively to the progress and direction of the Christian church. Augustine of Hippo and Athanasius of Alexandria are examples. Also, throughout church history, there are a number of people, such as Origen, whose contributions were rejected simply because they are erroneous. Some theologians had a detrimental impact on Christianity. Arianism, for example, would haunt the church for hundreds of years before its theories were largely eradicated, though it still exists in subtle forms today. A few personalities qualify for a fourth

category. Their teachings were rejected because they are erroneous and yet had both a positive and negative impact on the church. Marcion, "one of the most noted and most permanently influential of the heretics of the second century," qualifies for this fourth category.



Paul's epistles caused Marcion to travel down his illfated theological path. Marcion began to see a sharp and direct contrast between the law of the Old Testament (O.T.) and the agape love repre-

sented by Jesus Christ. Using Galatians and Romans as his primary sources, Marcion found a perfectly reasoned treatise that enlightened his view of the Christian faith, especially as it contrasted the O.T. What he concluded was that. "Christ represented and proclaimed an entirely new God." This new God became the foundation for Marcion's entire theology. His thought process led to the idea that religion is nothing more than belief in a redeemer-God, who through his love and complete mercy transforms man. .

Upon further comparison of the O.T. with the new God, Marcion found that the God of the O.T. was irreconcilably different from the God revealed through Jesus Christ. He believed there was no alternative but to reject the O.T. as a religious document, though he did believe the O.T was an accurate accounting of Israel's history. The radical theological conclusion caused by rejecting the O.T. led him to develop a doctrine of dualism that forced him to announce the reality of two distinct Gods. He proclaimed the God of Jesus to be far superior to, and totally separate from the creator God of the O.T. Thus, the purpose of Jesus was to reveal the new God who is total love and mercy without wrath or forthcoming judgment. Marcion deduced all of these beliefs from Paul's writings. He believed Paul was the only true apostle and the only one to comprehend fully the revelations given by Christ.



In A.D. 144, Marcion started his own church and produced the first great schism in the Christian church called the Marcionite Heresy.


Marcion's church was not a little sect. Indeed, Marcionism nearly overran the Catholic Church. The Marcionite church built its own schools, it had a hierarchy of Bishops and elders, and the movement spread as far as China. While it is difficult to trace any further influences today, the Marcionite church still exists on-line, though any real influence is non-existent, although you can still buy a Marcionite Bible on Amazon for \$9.99 or get the Kindle version for .99 cents, and it is a "Best Seller."

From the dates of the various letters and dissertations, we can deduce that Marcionism was most threatening to the established church from the midsecond century into the beginning of the third century. Many notable church leaders wrote against Marcionism. Indeed, it seemed "everywhere people were writing against the dreadful devilish sect." The Marcionite church was a powerful force in the second century. One could not travel anywhere without finding a Marcionite congregation. Marcion did in one generation what the Catholic Church took one hundred fifty years to accomplish. Everyone could wor-

ship in a Marcionite church, including pagans. Marcion did not intend to be a separate church. He wanted to absorb all of Christianity into his church, and he was nearly successful. Without a doubt, Marcion successfully carried out his threat of schism.

Obviously, the church noticed Marcion's efforts. Herein lies the positive outcome of Marcion's work, of which there are two. First, the church was compelled to develop a canon of Scripture. The process of development did not occur via a gathering of decision-makers. Rather a gradual consensus was the means of approving the initial canon. "Thus, by the end of the second century, the core of the canon was established: the four Gospels, Acts, and the Pauline Epistles." By the middle of the fourth century, a complete consensus of canonical books had been achieved. Thus, Christians owe, somewhat, a debt of gratitude to Marcion for his heretical effort for it ultimately yielded the New Testament. Secondly, the church was also forced into a nearly three century effort to clarify the connection between the Old Testament and the New Testament that led to the affirmation that the Hebrew Scriptures were canonical and must be retained as God's word. Though many other factors played into the formation of the canon, nonetheless this was arguably Marcion's greatest contribution to Christianity: The entire canon of Scripture including both the Old and New Testaments.

While he had a long-range positive impact on the church, he nearly destroyed it as well. However, as with all heresies throughout church history, the truth always "bubbles" back to the top despite those that persist in believing the heretics. The heresies of our time will do the same though only God knows when.

While it's helpful and necessary for children to interact and build relationships with people of all ages in the church, they especially need to see their parents living for Jesus in the power of the Holy Spirit.



#### ST. LUKE'S UMC LEADERSHIP MEETING JULY 21, 2022

The meeting was called to order by Jody Herb. Pastor Dan led in the opening prayer. The sole purpose of this meeting was to hold a vote to join a with the legal action being brought by the NCLL (The National Center for Life and Liberty) working with churches who desire disaffili-



ation from the United Methodist Conference due to the imposed sanctions recently developed by our Bishop. The cost per church is \$100 a month or \$1000 a year and a filing fee between \$1500 and \$2500.

Pastor Dan began by explaining the current events as shared in his weekly newsletter and to open the floor for general discussion. Following the discussion a paper vote was taken. The results of the Vote were as follows:

8 - Yes - Join the legal action

6 - No

2 – Abstentions

The church has been contacted by anonymous private donors who have agreed to cover all legal fees. No church money will be used in this endeavor. This action **DOES NOT** mean we have voted to formally disaffiliate, this would require a full 2/3 majority full congregational vote.

#### July 7th, 2022, Charge Conference Meeting Minutes

The meeting was opened in prayer at 5:00pm by Pastor Dan Gedman.

Pastor Gedman explained the purpose of the Charge Conference (to discuss and vote upon the Trustee's Resolution to sell the St. Luke's Parsonage) and then read the text of the resolution (which was also provided in printed form to all in attendance.)

Pastor Dan opened the floor for questions and discussion.

Reverend Davis asked if there is a sale price being considered, as well as what the cost of renovations would be. Chuck Dean (one of the Trustees) responded that the real estate agent thought it should be listed for \$340K, and that, with lead pipes and likely asbestos in the house, as well as major repairs needed on both porches and the kitchen, the cost of repairs would be nearly the value of the house. Chuck and Pastor Dan also explained that, because the house is in the Denton Historic District, the permitting process of any renovations would be more complicated and expensive.

Doug Collison, the Chair of the District Building and Location Committee attending the meeting, asked if the Trustees and/or leadership had considered renting the property (since there are so few rentals in the area). The Trustees and Leadership chair confirmed they had explored this option, but since the costs of repairs and renovations were so high, the church would likely never recover the costs necessary for rental. Also, the church would lose its non-profit status for property taxes if the property were rented, adding further to the costs associated with the property.

Pastor Dan asked if there were any further questions or concerns, and there being none, Jim Orr made a motion to vote upon the resolution, which Ruth Hynson-Palmer seconded.

By a show of hands of those present, the majority voted to pass the resolution from the Trustees to sell the parsonage.

Doug Collison explained the next step in the process was to send to the Building and Location committee a signed copy of the resolution, and the resolution was duly signed by Pastor Dan, the Chair of the Church Council, the Chair of the Board of Trustees, and three other members of the Board of Trustees.

Pastor Dan closed the meeting in prayer.

## New St Luke's Directory


We are still working on our online church directory to get it correctly formatted (we hit a few hiccups...)


